### **Modern Slavery Policy Statement**

Although not required to publish an annual statement setting out what we have done to eradicate slavery and human trafficking from our supply chains and operations, Shap has chosen to produce this Policy Statement.

#### 1. Overview

- 1.1 Shap has a zero-tolerance approach to modern slavery and is committed to acting ethically and with integrity in all our business dealings and relationships and to implementing and enforcing effective systems and controls to ensure modern slavery is not taking place anywhere in our own business or in any of our supply chains.
- 1.2 As an organisation committed to social justice, we expect the same high standards from all of our contractors, suppliers and other business partners in regards to modern slavery.

#### 2. Our Structure

- 2.1 SHAP is a value based charitable organisation that strives to makes a real difference for people and communities. From its beginnings as a single, 8 bed hostel, Shap is now a highly regarded, innovative, practical and financially viable charity and voluntary organisation that works to sustain communities, reduce homelessness, increase the health and wellbeing of vulnerable adults and young people and improve the life chances of the next generation. - 4.2 Our Supplier Code of Conduct reflects our commitment to acting ethically and with integrity in all our business relationships and to implementing and enforcing effective systems and controls to ensure slavery and human trafficking is not taking place anywhere in our supply chains.
- 4.3 In terms of employee recruitment, we undertake all relevant pre-employment checks prior to colleagues being employed, to ensure they are eligible to work in the UK. We carry out fair and transparent recruitment processes and ensure that our recruitment agencies comply with these requirements in the provision of agency staff.
